1. My child and I have read and understood the Run Regulations.
2. My child has undergone a medical examination and has no medical contraindications for participating in the Run. I commit that, in case of any deterioration in my child's health before the Run, they will not take part in the Run.
3. My child and I acknowledge all the risks associated with participating in the Run and understand that such participation may result in adverse health consequences. I take full responsibility for the safety and health of my child.
4. In the event of an accident during or after the Run, injury, or physical damage, as well as loss or damage to my or my child's property, both I and my child voluntarily and knowingly waive any material or other claims against the Organizer.
5. I confirm that neither I nor my child will intentionally create situations before, during, or after the Run that may cause harm to other participants, the Organizer, third parties, or their property.
6. My child and I consent to being photographed and filmed during the Run, and grant permission to publish, reproduce, and distribute our images (photographs and/or video footage) in any way and by any means, without time or territorial restrictions.
7. In case of COVID-19 symptoms/signs in me or my child and/or confirmed contact with infected individuals, or confirmed COVID-19 diagnosis (via PCR test and/or rapid antigen test), I commit to informing the Organizer in advance to determine further actions.
8. My child and I agree to comply with all COVID-19 prevention measures in accordance with the decree of the Chief State Sanitary Doctor of the Republic of Kazakhstan "On further strengthening of measures to prevent coronavirus infection among the population of the Republic of Kazakhstan," as valid at the time of the Run.

9. This consent is provided free of charge.

10. This consent also applies to my potential heirs and legal guardians and remains in force before, during, and after the Run.
